

Motion concerning procedures for re-considering of decisions made at face to face meetings - voted on by ICFRA Council, via email on 17 January 2008

**Be it resolved that any rule approved in face to face committee meetings by a majority of members and subsequently passed by a majority of councillors in face to face meetings shall become effective immediately after approval and may only be reconsidered by a committee on approval of a majority of councillors entitled to vote as members of the ICFRA Council, on behalf of which the Secretary General shall on such majority vote refer the rule to the relevant committee(s) for reconsideration. The relevant committee(s) shall report their reconsidered decision through the Secretary General to the Council within 180 days of the decision of Council to refer, in the absence of which report the original rule shall stand and shall not be again referred unless a face to face meeting of the Council so decide. No rule may be reconsidered or referred to a committee without the approval of the ICFRA Council.**

Voting: 2 in favour; 15 opposed; 0 abstentions The motion failed in accordance with the rule requiring 75% voting and 75% of those in favour for electronic votes.

Motions concerning an appeal by the Irish Rifle Club (Bisley) against the decision of the General Assembly of ICFRA to decline its application for membership of ICFRA - voted on by ICFRA Council, via email on 24 February 2008

- 1. That the Council set aside the decision of the Appeal Committee that heard the original appeal by the IRC(B) and set out its decision on 30 August 2007.**
- 2. That the Council appoint a Membership Appeals Committee to re-hear the Appeal by the IRC(B) against the Decision of the ICFRA Council of 15 August 2007 to deny full membership of ICFRA to the IRC(B). The Committee shall report its findings to the ICFRA Council.**
- 3. That the committee be comprised of 5 individuals drawn from member bodies of the Confederation who shall be persons held in high regard and shall not include any person who took part in the ICFRA General Assembly and Council meeting of 15 August 2007 or any person who has an interest in the IRC(B) or NRAI.**
- 4. That those members that wish to nominate persons from within their own NRA, or from another NRA that is a member of ICFRA, shall do so to the Secretary General and shall attach a brief resume of the nominee's credentials. It would be preferable for some nominees to have legal experience and training. The Councillors shall each then vote electronically for up to 5 of the nominees and the 5 obtaining the highest votes shall become the Membership Appeals Committee. The nominee with the highest vote shall be the convenor of the committee and direct and co-ordinate its deliberations. The committee shall consider all matters relevant to appeal as it sees fit.**

Voting on all motions: 6 in favour; 6 opposed; 3 abstentions The motions all failed in accordance with the rule requiring 75% voting and 75% of those in favour for electronic votes.

Motion to confirm new wording of the “One year rule” for making rule changes – voted on by ICFRA Council, via email, 28 June 2008

**Changes to Technical Rules and Match Conditions must be complete within 1 year after the conduct of the relevant Match(es):-**

**Provided always that a change necessitated by safety, security or legislative pressures may be considered on the arising of the issue;**

**And provided that restrictions on a host nation for domestic legislative or insurance reasons are promulgated with match entry forms.**

**In relation to proposals to amend Technical Rules, proposals should be submitted 9 months in advance of the commencement of the World Championship at which the Committee concerned will meet. This is to allow preliminary consideration out of Committee and proper placing on Agendas.**

**Proposals for change must be submitted to the Chairman of the relevant Committee with copies to the Secretary General and IRRG Members. Proposals for changes to (only) Match Conditions may alternatively be lodged with the Match Referee as provided in T1.5.2.**

Voting: 14 in favour; 0 opposed; 2 abstentions The motion passed in accordance with the rule requiring 75% voting and 75% of those in favour for electronic votes.
